6. The internal market of the European Union, including public competition rules, state aid, and corporate taxation.
7. Constitutional freedoms and human and civil rights in relations between individuals and public authorities, unrelated to the fields listed above.

**K2 Consult Sp. z o.o. does not accept anonymous reports.**

The personal data of individuals reporting a violation and individuals implicated in the report will be processed based on Article 6(1)(c) of the GDPR in connection with Article 17 of Directive (EU) 2019/1937 of the European Parliament and Council on the protection of persons reporting breaches of Union law (legal obligation) and Article 6(1)(f) of the GDPR (legitimate interests of K2 Consult Sp. z o.o., Gorzew 19, 95-200 Pabianice, as the data controller).
